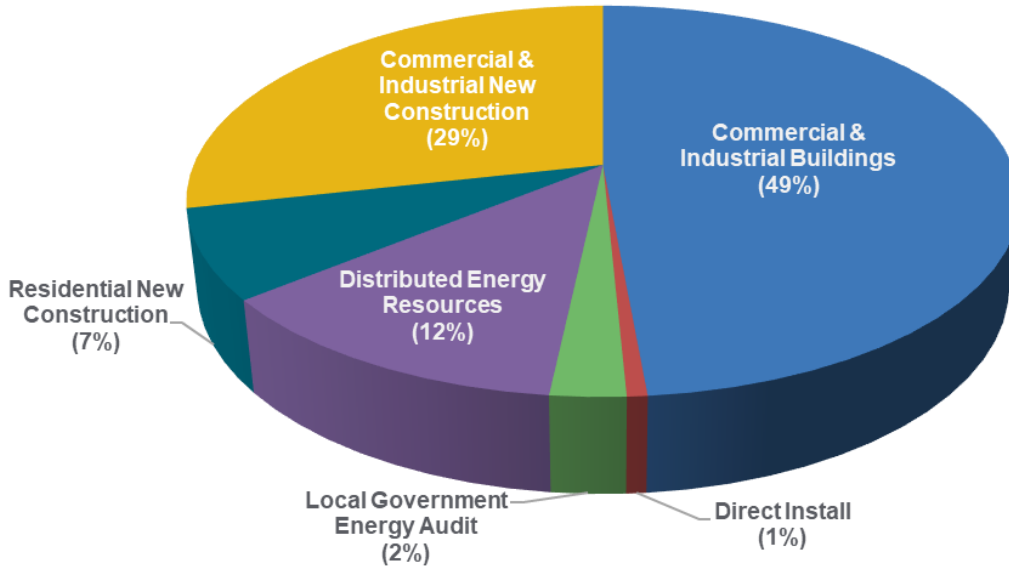

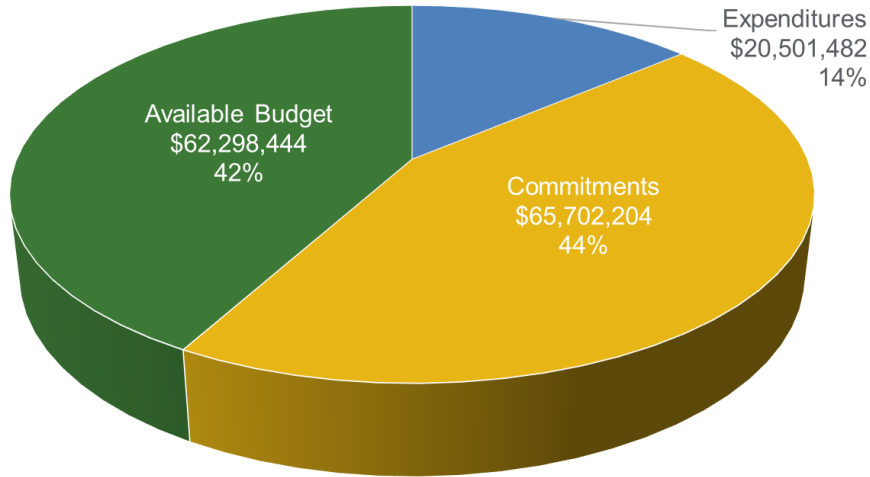

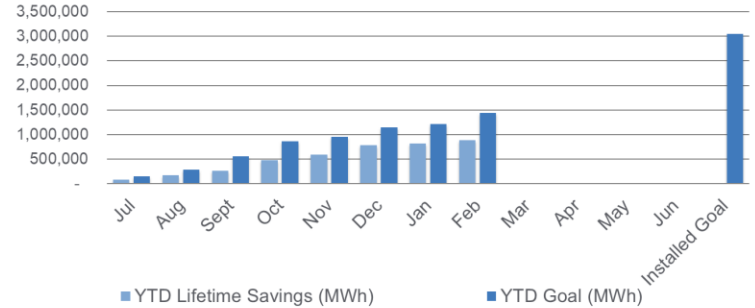

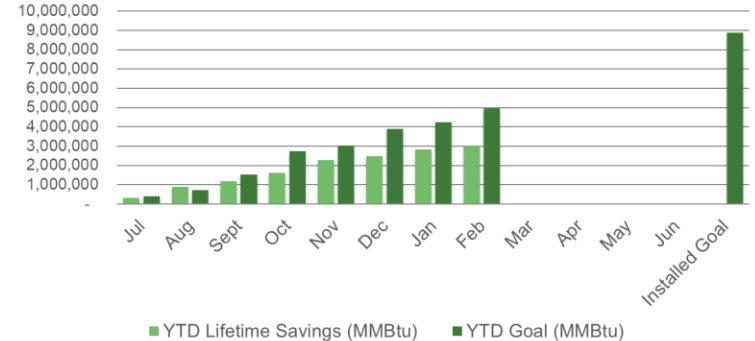

YTD Lifetime Electric Savings (MWh)

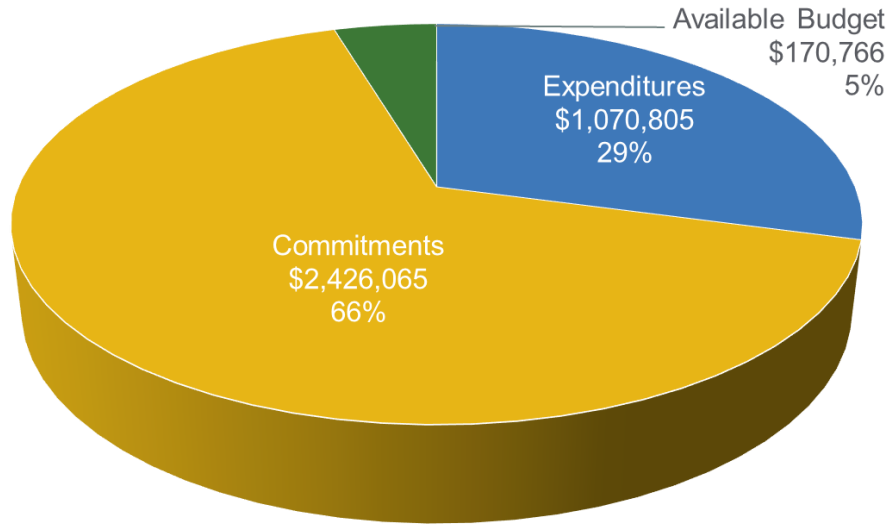


FY24 Overall Progress Towards TRC Managed Program Goals

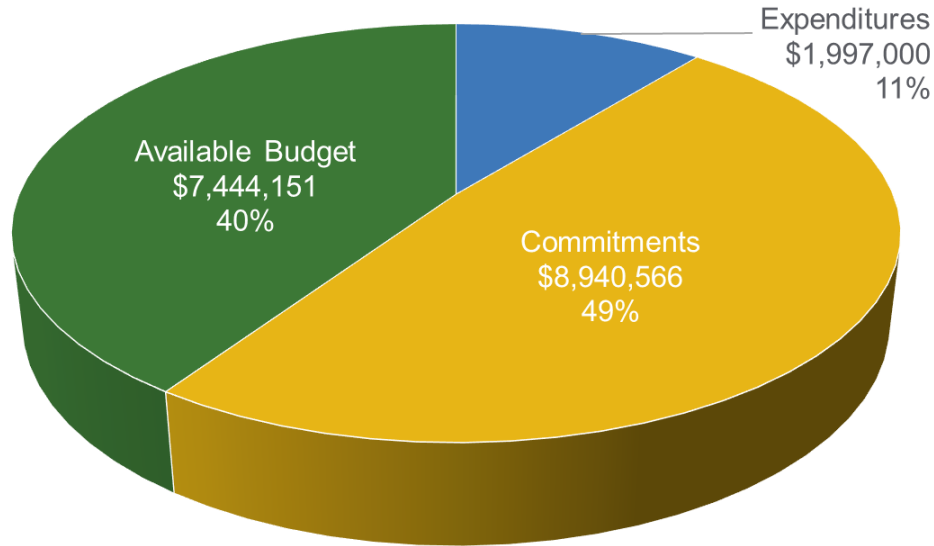

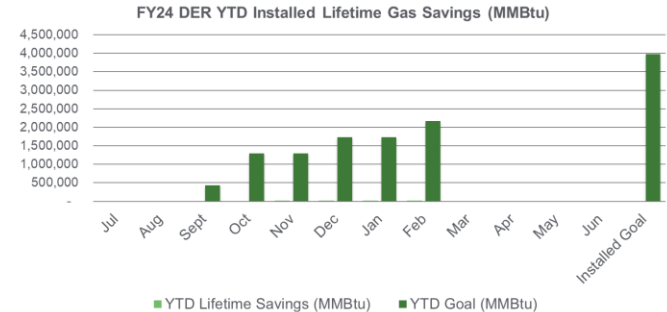

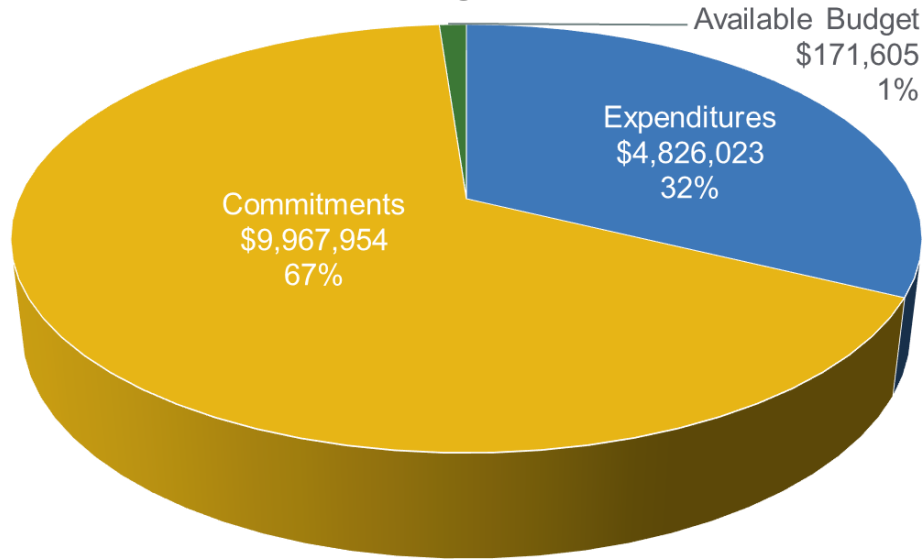

Residential New Construction

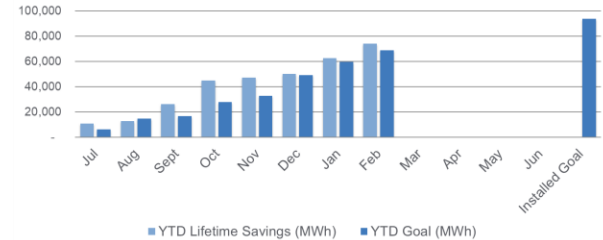

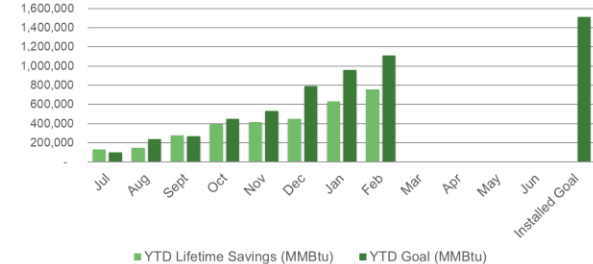

FY24 RNC YTD Installed Lifetime Electric Savings (MWh)



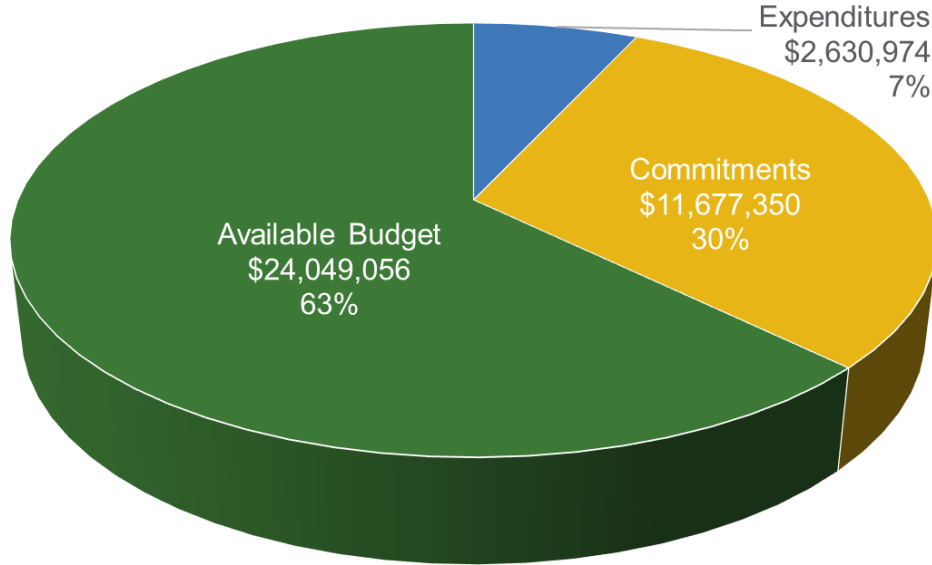
FY24 RNC YTD Installed Lifetime Gas Savings (MMBtu)

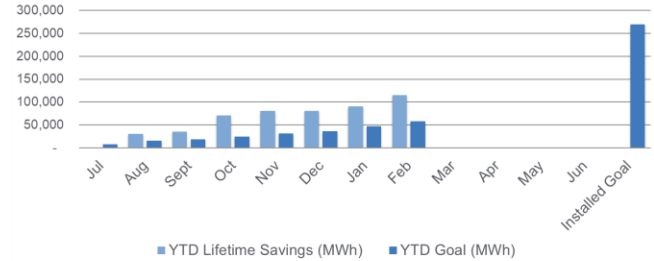

FY24 C&I NC YTD Installed Lifetime Electric Savings (MWh)

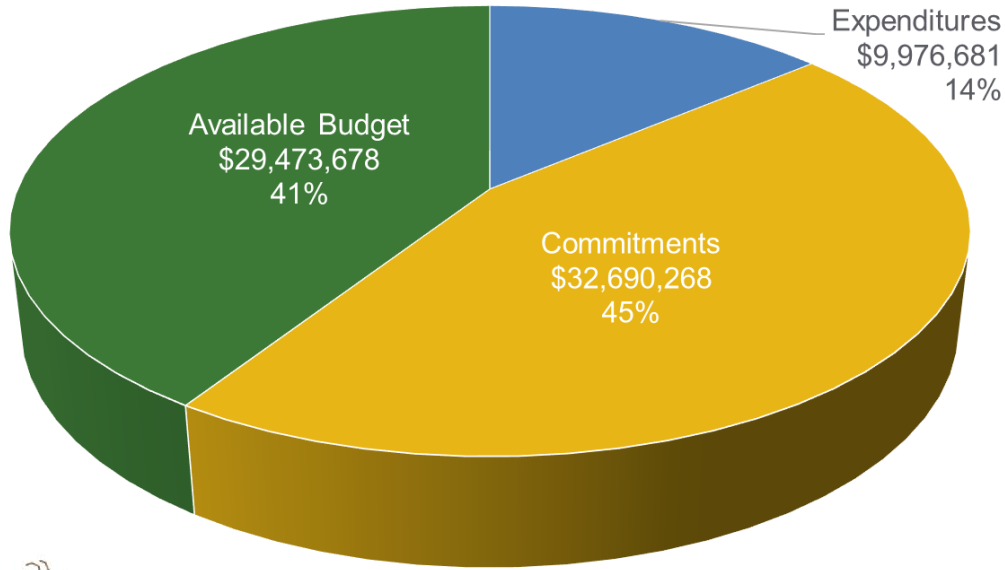


FY24 C&I NC YTD Installed Lifetime Gas Savings (MMBtu)

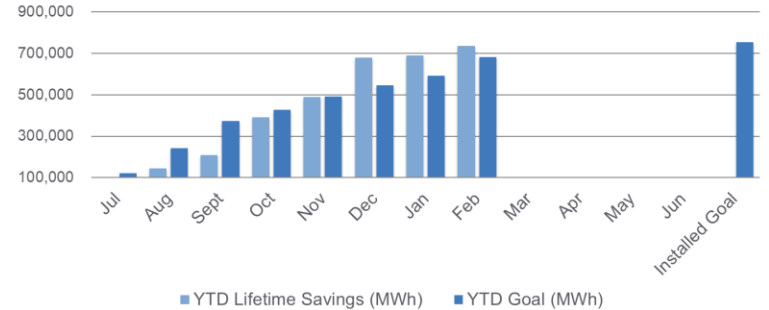

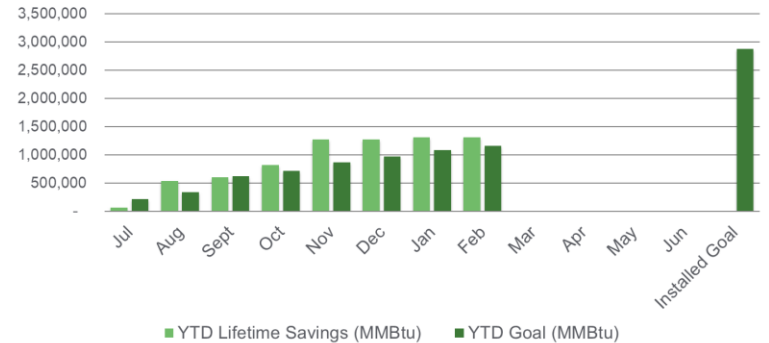
