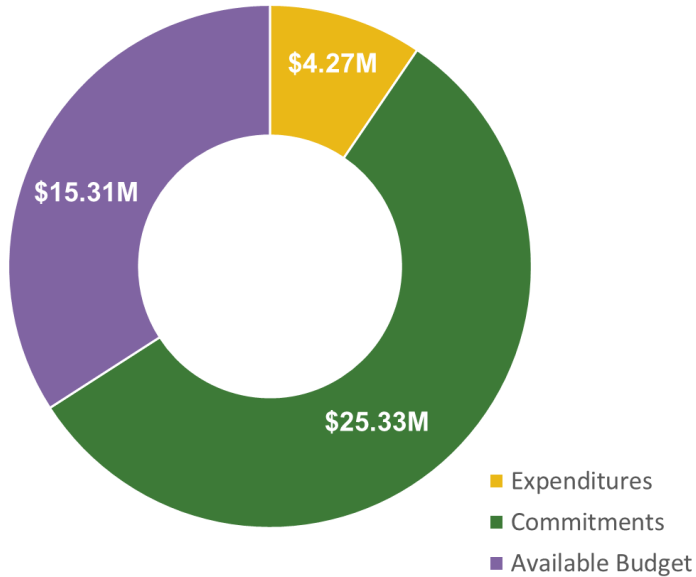

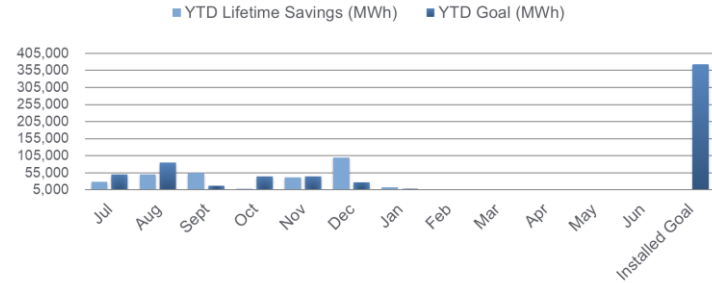


Commercial & Industrial Buildings Programs: P4P EB, LEUP

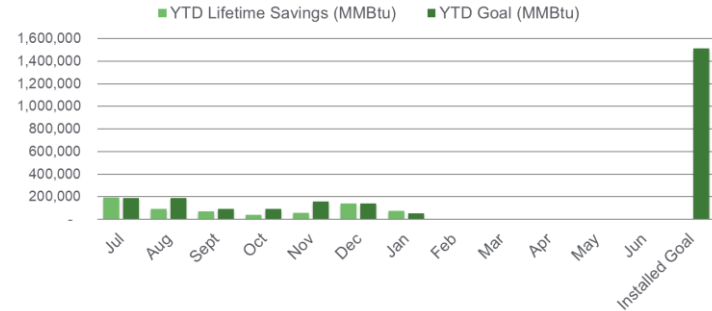

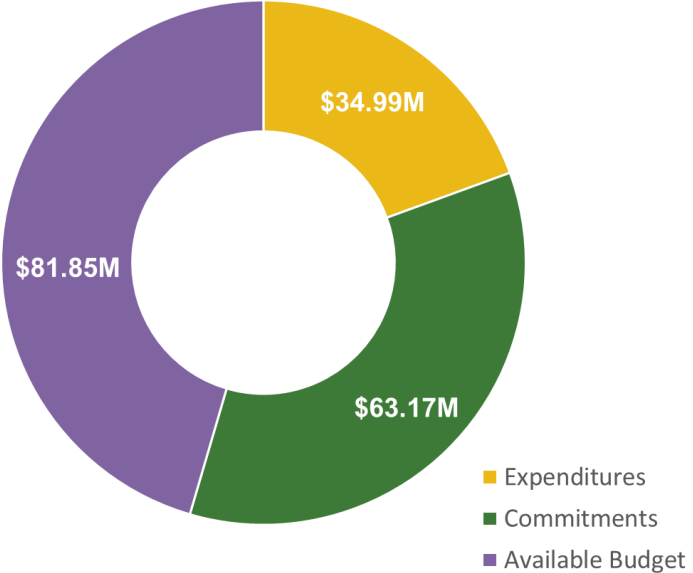

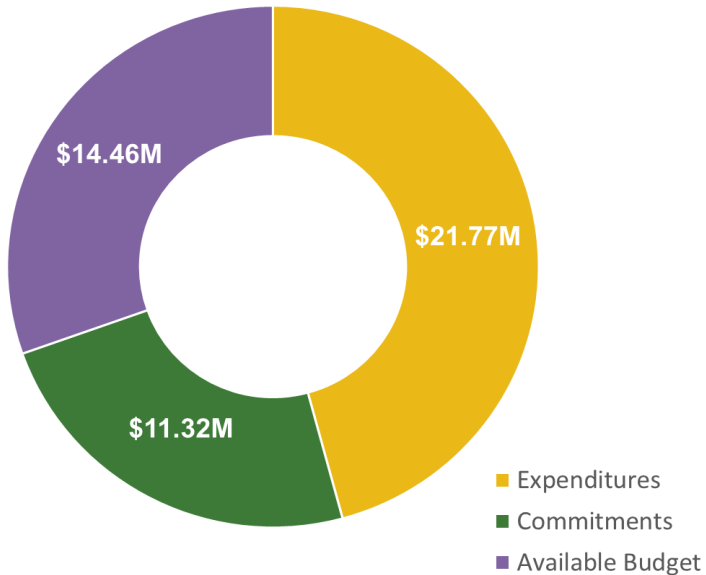
